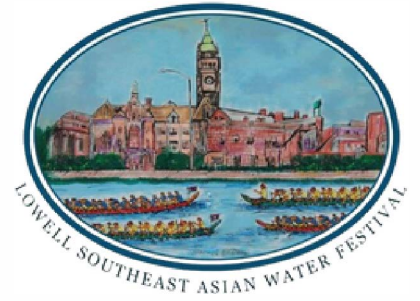

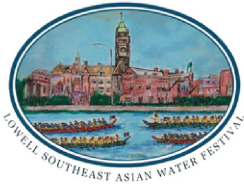

PERFORMER APPLICATION

- I must maintain all health and safety protocols as outlined by the City of Lowell, public health officials, the Department of Conservation & Recreation, and the State of Massachusetts.
- Festival performers are scheduled according to space and availability. Past performance does not guarantee inclusion in this year's festival. I understand there is a stage time limit and will adhere to it. Performance time and duration will be finalized and settled after acceptance into the program.
- Selected applicants will be contacted by within a week of submission. Main stage scheduling is typically finalized 2 weeks before the event.
- I, or a member of the group, is responsible for the supervision of minor performers during the entire event. All performers must sign and submit Waivers.
- The group will check-in at the appropriate Performer's check-in tent at the stage at least 30 minutes prior to performance. Stage schedule will be finalized later.
- If my group is chosen to perform, I understand that I may have to submit any supplementary material timely. An e-mail with requests will be sent upon selection. (Materials may include, 300 dpi promo photo, photo consent and release, audio recording for stage performance, lyrics, etc)
- I understand that the Water Festival is a family-friendly event and will guarantee that the performance and music is age appropriate. Lyrics and music will be approved ahead of time and I understand that if the performance is deemed inappropriate, it may be stopped mid-performance during the Water Festival. (Clean music and culturally appropriate clothing only.)
- I will provide a list of any equipment and instruments the group will bring for the performance on a separate sheet and send along with this two-page application, if equipment list cannot fit below:

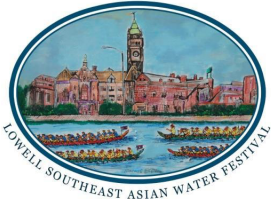

Release and Waiver of Liability Assumption of Risk and Indemnity Agreement For Performers (“Agreement”)

The Lowell Southeast Asian Water Festival operates under the fiscal sponsorship of the Greater Lowell Community Foundation, a 501(c)(3) public charity. In consideration of permission to participate in the Lowell Southeast Asian Water Festival and related events and activities, I acknowledge that:

- Rules.** I agree to abide by all rules and regulations of the Lowell Southeast Asian Water Festival regarding safety and use of any and all equipment. I agree not to consume drugs or alcoholic beverages during Festival activities and agree to leave the premises and/or immediately cease my Festival activity, if suspected to be under the influence of same.
- Waiver and Release.** I hereby freely, knowingly, expressly and specifically assume the risk of any injury or harm in these activities. In consideration of being allowed to participate in this event, on behalf of myself and anyone entitled to act on my behalf, and to the fullest extent permitted by the law, I hereby waive, release, hold harmless and promise not to sue the Lowell Southeast Asian Water Festival, its officers, officials, agents, consultants, employees, and sponsors in connection with all claims or liabilities, of any kind whatsoever, arising out of, or in any way relating to, my participation in the Festival.
